TERMS AND CONDITIONS

1. I am a bona fide resident of the City of Grosse Pointe Park and the address given is my actual principal place of abode. I own and principally use the described boat and the information given in this agreement is true and correct. In the event of any change, I will promptly notify the City.
2. Enclosed is a copy of my CURRENT and validated by the Secretary of State registration.
3. I have read the City Council's Statement of Policy and the City Manager's Rules and Regulations relating to the Marina. I will cooperate in effecting the Statement of Policy and I will abide by the Rules and Regulations, as from time to time in force, for the operation of the Marina.
4. I will be responsible for all my guests. The use of said Marina by me and my guests will be at our own risk. I will indemnify the City and its agents and employees against any claim by me, my guests or others for damages arising as a consequence of my boat being in the Marina or on account of the presence of me or any of my guests in the Marina.
