## **PREFACE**

This Code constitutes a complete re-codification of the ordinances of the City of Grosse Pointe Park of a general and permanent nature. As expressed in the Adopting Ordinance, the Code supersedes all such ordinances not including herein or recognized as continuing in force by reference thereto.

The chapters of the Code are arranged in alphabetical order and the sections within each chapter have been catch-lined to facilitate usage. Source materials used in the preparation of the Code were the 1983 Code and ordinances subsequently adopted by the City Council. The source of each section is include in the history note appear in parentheses at the end thereof.

### **Numbering System**

Each section number consists of two component parts separated by a dash. The figure before the dash represents the chapter number and the figure after the dash represents the position of the section within the chapter. Thus, the first section of Chapter 1 is numbered 1-1 and the third section of Chapter 4 is 4-3.

### **Loose-leaf Supplements**

A loose-leaf system of binding and supplemental service has been used by which the Code will be kept up-to-date periodically. New or amendatory ordinances will be reprinted. The new pages will be available for distribution to holders of copies of the Code, with instructions for inserting the new pages and deleting the obsolete pages.

The updating of this volume will depend largely upon the holder of the volume. As revised pages are available, the holder should immediately secure and insert them. All such

amendments should be inserted according to the instructions provided immediately upon receipt to avoid misplacing them.
