Lindell Lodge/Patio Rental Guidelines

The Lindell Lodge can be rented from **April 15 - November 15 (including holidays)** to Grosse Pointe Park residents and their guests. Call the Parks and Recreation Office for additional information or to reserve a date at 822-2812, Ext. 201.

Features:

There is a 32" high definition flat screen television and a surround sound stereo system. A gas fireplace, 2 leather club chairs and 2 wooden cafe tables with accompanying wooden chairs. The side windows open and there is a ceiling fan. There also is a handicap accessible restroom and overhead lighting.

Building Rules:

No smoking allowed inside and no wall decorations.

Balloons and table decorations are allowed.

An "as is" rental room. You may bring an extra serving table.

There are plenty of electrical outlets to warm food. No refrigeration is available. Coolers may be brought in.

Counters may be used for serving food. There is no kitchen, sink, or serving utensils.

Please do not use bathroom sink for cleaning purposes.

Garbage must be taken out to dumpsters in parking lot.

Patio is included in rental.

Capacity: 25 people.

Permitted functions: Teas, clubs, birthday parties, card parties, meetings.

Rental Fee & Security Deposit: The **Rental Fee** is \$75 for Monday–Friday and \$125 for Saturdays, Sundays, and Holidays. This fee is due within 2 weeks of booking. A **Security Deposit** of \$100 is required on all rentals and is due 1 week before rental. Two separate checks (1 for rental and 1 for security deposit) must be submitted. All or part of the Security Deposit will be kept if the building is left dirty or property is damaged or destroyed. The Parks and Recreation Staff will make this determination.

NO REFUNDS.

Both checks should be made out to "City of Grosse Pointe Park".

The undersigned is in agreement with and will comply with the terms and conditions on the application. Applicant will hold harmless the City of Grosse Pointe Park, its representatives, agents, officers, employees and volunteers for any personal injury, theft or damage to private property. Permit will not be validated until Rental Fee and Security Deposit are paid.
